SAINT PAUL'S CEMETERY
General Rules and Regulations

1. **Arrangements for all interments** are to be made with the Superintendent.
2. **Concrete outer burial containers are required for all interments.**
Any concrete vault may be used, however the minimum will be a concrete grave box. The purpose of this container is to encase the casket, providing protection from any disturbance at the time of future adjacent burials and to prevent excessive settling of the grave. Exceptions to this rule will be made for infant and cremains burials.
3. **Floral decorations are permitted for Memorial Day**, but must be removed by June 15th.
A permanent stand or vase for flowers and/or potted plants is permitted, as long as it does not interfere with mowing of the grass. **Planting of flowers or shrubs is prohibited.**
4. **MEMORIALS - Upright monuments and flat markers.**
 - A. **Notification of the Superintendent is required** before placing a monument or marker.
The Superintendent will mark the location for placement.
 - B. Monuments and markers are to be made of **granite or bronze only**.
 - C. **Foundations** for monuments are to be made of concrete and should be a precast slab. The slab should be 4" thick and large enough to provide a 3" border on each side of the base of the monument. All excess dirt and waste material should be removed and no damage to other monuments, markers or cemetery grounds incurred.
 - D. **Flat markers must be set in concrete** with a 3" border on each side. The top of the marker must be level with the surface of the ground.
 - E. Only one upright monument will be allowed on each four grave lot.
 - F. **Engraving** on monuments will **only** be allowed on the side of the monument where the purchaser controls the right of interment.
 - G. **No temporary markers are permitted.**
 - H. **Permanent monuments or markers are required within one year of burial.**
 - I. Any firm or person found in violation of the rules pertaining to monuments and markers, will be barred from doing further work in the cemetery. When all violations have been corrected, the cemetery board may grant permission for the violator to again do work in the cemetery.
5. **Ownership is limited to the right of interment only** and is verified by the Right to Control Interment Agreement.
6. **Right of interment is limited** to one interment per grave.
That interment may be of one body or the remains of one body or one cremains.
The right to inter a second cremains in a grave may be purchased for the same price as a single grave.
